GREINER IMAGE USE COPYRIGHT AGREEMENT

GENERAL

1. Professional artist, Max Greiner, Jr. (Max Greiner, Jr. Designs, LLC) is referred to as “Greiner” in this legal document.
2. The different forms of original Greiner “Intellectual Property” are referred to as “Work”.
3. All Max Greiner Jr. sculpture, drawings, paintings, cartoons, logos, designs, photography, architecture, graphics, writing, speeches, Power Point presentations, websites, audio and video presentations are Greiner Work and are protected by Copyright and in some cases, Trademark registration, in the USA, and other countries where USA rights are respected.
4. All Greiner Work is copyrighted from the moment of creation by Greiner.
5. Max Greiner, Jr. Designs, LLC allows for both “Commercial” and “Non-commercial” use of Greiner Work, with permission.
6. Both “Commercial” and “Non-commercial” use of Greiner Work requires a Copyright and Trademark Notations be posted on, or near the Work.
7. “Commercial” use of Greiner Work requires either a Short-Term or Long-Term Licensing Agreement. A Royalty fee will be determined on a case-by-case basis.
8. Greiner art product names and logo symbols are trademarked. Some are also officially “Registered” ® with the Trademark Office in Washington D.C. (The “TM” Trademark notation is used with composition names and logos that have not yet received the official Registration ® designation from the Trademark Office in Washington DC.)
9. Greiner composition names cannot be legally used without advance written permission.
10. Reproducing Greiner Work in any way, without written permission may constitute infringement of Greiner Copyrights and Trademarks. (This infringement may also violate existing contractual Agreements with other Licensees. Therefore, unauthorized “Commercial Use” of Greiner work and trademarked names is subject to civil and criminal prosecution.)
11. Owning Greiner Work does not constitute ownership of Greiner Reproduction Rights. No one can reproduce or sell Greiner Work without a written Licensing Agreement.
12. Artists and photographers cannot depict Greiner copyrighted Work within their own original compositions, without written permission from Greiner.
13. Greiner Copyrights and Trademarks are NOT FOR SALE. They are owned by exclusively by Max Greiner, Jr. Designs, LLC.
14. Greiner Work (or the Artist’s likeness) cannot be used, copied or reproduced, sold, rented or placed on other items, advertising or websites, without advance written approval from Greiner.

NON-COMMERCIAL USE

1. Images of Greiner Work and likeness may be featured (including posting on social media and websites) without charge for “Non-Commercial” use, if properly notated.
2. Individuals, churches, ministries, charities and educational institutions can use their own photographic images of Greiner Work and Greiner original photographic images (without cost) as long as Greiner’s standard Copyright Notice is clearly visible to a viewer looking for the legal Copyright and Trademark notice.
3. The “Non-Commercial Use Agreement” form below must be submitted to Greiner for permission.
4. Greiner’s Copyright and Trademark notices must always be posted on any, and all, reproductions depicting Greiner Work.
5. Infringement occurs when Greiner Work is not protected with a proper Copyright and Trademark notice.
6. Greiner Work (Intellectual Property) includes, but is not limited to: “*Divine Servant*”® , the “*Christian Butterfly*”®, “*Fisher Of Men*”®, “*The Great Commission*”®, “*The Coming King*”®, “*Sword Of The Spirit*”®, the “*Art Of Faith*”®, “*The Empty Cross*”™, the “*Lion Of Judah*”™, “*Yeshua*”™ and the “*Isaiah Eagle*”™ and “*American Eagle*”™.
7. Proper Legal Notice consists of at minimum: a) name of the artist, Max Greiner, Jr., b) Copyright and or Trademark symbols. This Legal Notice must be legible, visible on or near reproduced image itself. This Legal Notice can be subtle, in any color, size or font. However, the Legal Notice must be obvious to anyone looking for the Notice.

9. Greiner Permitted Use Requirements:
 - a) Social Media: **“*Divine Servant*”® is the Copyrighted & Trademarked creation of Max Greiner, Jr Designs LLC ©**
 - b) Websites: Same
 - c). E-Blasts & Blogs: Same
 - d). Print Media: Same
 - e) Videos: Same. However, Greiner’s “*Christian Butterfly*”® logo should be presented at end of the film in Credits, with the Greiner name.
10. Greiner Logos – Greiner Copyrighted and Trademarked logos, or images of Greiner art, cannot be used or incorporated into the registered logos of other organizations or individuals.

COMMERCIAL USE

Please return this signed form to Greiner for “Non-Commercial” permission.

For “Commercial Use” of Greiner Work, please contact the Greiner Office. Typically, a 3% “Royalty Fee” is required (of the Purchase Price) of any and all products sold, which depict Greiner Work. Royalties must be paid by a Licensee to Greiner on a monthly basis. These records are subject to audit.

Authorized Licensees must always display the Greiner Copyright notice and Trademarked Butterfly logo, which identifies Authorized “Commercial Use”.

All parties seeking to be Authorized Commercial Licensees, for the purpose of creating and selling products featuring Greiner Work (Intellectual Property) must sign a formal “Licensing Agreement” with Greiner.
